

# **OFFICIAL RULES** \$100 DoorDash Gift Card Raffle

## 1. Eligibility

- Open only to legal residents of the United States, 18 years of age or older.
- Entrants must be current Workday customers or prospects to qualify.

- Limit: **One (1) entry per person** during the Promotion Period. Any attempt to submit multiple entries may result in disqualification.
- No purchase necessary to enter or win.

#### 5. Prize

- One (1) winner will receive a \$100 DoorDash electronic gift card (the "Prize").
- The gift card will be delivered electronically to the winner's email address.
- Approximate Retail Value ("ARV"): \$100.
- Prize is non-transferable, non-exchangeable, and cannot be redeemed for cash or other substitutions. Sponsor reserves the right to substitute a prize of equal or greater value if the advertised prize becomes unavailable.

#### 6. Winner Selection and Odds
